At Settle Area Swimming Pool, we can offer two types of swimming pool parties but we have strict guidelines to ensure the safety of you and your guests;

For a pool **inflatable** party, maximum 35 bathers - £180.00 – 1 hour in pool/2 hours FitSpace room hire For a **pool only (plus toys)** party, maximum 35 bathers - £140.00 – 1 hour in pool/2 hours FitSpace room hire

Private hire includes use of small room in the FitSpace and the kitchen. Time using these area is limited to 2 hours.

## **General rules**

- In an attempt to keep chemical usage to a minimum, for the comfort of all and our costs down, swimmers MUST shower thoroughly before entering the pool.
- Please ensure all children use the toilet and blow their noses before entering the pool and that swim nappies are used when required.
- If anyone has experienced ANY sickness or diarrhoea, then they must NOT swim for at least 14 days after complete recovery.
- Children under the age of 4 years must be accompanied by one adult to one child.
- Children under the age of 8 years must be accompanied by one adult to two children.
- Non and weak swimmers must be accompanied at all times and must remain in the areas where they can stand or within arm's reach of a responsible adult.
- Our Lifeguards may have to use whistles to control the session, in general this will be:
  - One whistle to attract the attention of a swimmer.
  - $\circ$   $\;$  Two whistles to attract the attention of another lifeguard.
  - Three whistles plus the Emergency Alarm on their walkie talkies means they are taking emergency action and will ask you to clear the pool.
  - $\circ$   $\,$  One long blast to signify the end of the session.

## **Terms and Conditions of Private Hire**

- 1. In the interest of hygiene and comfort of all swimmers, it is essential for everyone to shower thoroughly prior to entering pool.
- 2. Please ensure removal of all sharp objects including jewellery, watches, goggles, locker keys etc.
- 3. Non- confident or non- swimmers must wear floatation devices such as armbands and be accompanied by an appropriate adult at all times.
- 4. In the interest of safety, please respect the instructions given or special requests given from the Lifeguards.
- 5. The maximum numbers of bathers is: 35 (Inflatable) 35 (Pool only)

## NB: these figures cannot be exceeded under any circumstances.

- 6. Hirer will be shown emergency fire exits and assembly points prior to use of the building.
- 7. The party (pool/FitSpace) is not considered booked unless a £25 deposit is taken and a confirmation of booking is issued.
- 8. The hirer will only have access to the pool from 12.05pm until 1.05pm and access to the FitSpace from 12.05pm until 2pm, any additional time must be agreed with the Pool Manager and the hirer will be charged accordingly.
- 9. The hirer will be responsible for providing financial compensation to SASP and other users if damage to the property occurs.
- 10. Children when in the FitSpace must be accompanied by an adult at all times during use of the room and when leaving for access to the toilet which will be identified to the hirer.
- 11. In the event of a double booking the party that pays their deposit first will be deemed to have booked.
- 12. We do not hold dates provisionally for any hirer. Two weeks notice must be given for any private hire.
- 13. Settle Pool can cancel the party if outstanding fees are not paid 7 days before the party date, without giving notice.
- 14. If a hirer cancels the party prior to the 7 day booking deadline they will only forfeit their deposit.
- 15. If a hirer cancels within the 7 day deadline then the hirer will forfeit all fees paid and the balance becomes payable.
- 16. In the unlikely event of a fault (or maintenance issue) developing at the pool within area period of the hire we will offer;
  - a. A full refund or
  - b. An alternative booking date (with a 50% refund)
  - NB: we will contact the hirer at the earliest possible time to notify the hirer if this happens.

- 17. Hirers are not permitted to sublet any sessions, if this occurs any hire will become null and void.
- 18. Parties will also include use of the kitchen and a Member of Staff will be on site to supervise. The hirer must leave the space clean and tidy after use.
- 19. The hirer must leave the FitSpace in the same state as given, please take any rubbish away after use and leave the space clean and tidy.
- 20. There is strictly no access to the storage space behind the curtains in the FitSpace, any items that are unaccounted for will be charged accordingly.
